

EXTENSION OF BID SUBMISSION DATE

The National Empowerment Foundation invites Eligible and Qualified Bidders to participate in a sealed bid exercise for the following tenders:

a) Construction of 30 Conventional Social Housing Units for Vulnerable Households (SRM) Lot 4 (FY 2019-2020) Volume 1 of 2; NEF/OAB/07/2020.

b) Design & Construction of 30 Social Housing Units using Pre-Fabricated Materials for Vulnerable Households (SRM) Lot 4 (FY 2019-2020); NEF/OAB/08/2020.

1. Details of the requirements and conditions are contained in the Bid Document. Interested bidders may consult the Bid Document on 8th floor at the address given below from 0930 hours to 1200 hours and from 1245 hours to 1530 hours on working days.
2. Qualification requirement includes:
 - Bidders having the technical capacity, resources and sound financial situation; and
 - As per other qualifying criteria mentioned in the Bid Document.

One complete set of the Bid Document in English may be purchased by Eligible and Qualified Bidders on calling at the seat of the **NEF, 8th Floor, Garden Tower, La Poudrière Street, Port Louis**, within working hours and upon a payment of a non-refundable amount of Rs 1,000 (One thousand rupees) **per Bid Document**. The method of payment will be by **Bank cheque** only. **The cheques to be issued on the name of National Empowerment Foundation.**
